Mr. Jetter stated he thinks there was a timetable on that and noted the matter is concerning.

Mr. Weidman said he had a conference call scheduled with State Legislator Bill Seitz and will discuss the issue with him.

Mr. Jetter stated he thought the legislation would expire at the end of the emergency order.

Mr. Weidman asked Mr. Jetter if collections are ok in Deer Park.

Mr. Jetter stated tax collections in Deer Park are down \$50,000.00 but noted the city could break even as there have been a lot of people who asked for an extension.

Mr. Weidman asked if Mr. Jetter was seeing more foreclosures.

Mr. Jetter answered not so much on the residential side, but the large nursing home that is in foreclosure.

Budget:

Mr. Warrick reported the JEDZ were audited and one thing that came out of the audit is the requirement to have a budget. He showed the budget he created and asked Mr. Jetter if he had any changes.

Mr. Jetter stated he is ok with it.

Mr. LaBarbara motion to adopt the budget for 2020, seconded by Camp. Mr. Warrick called roll. All Aye.

Public Request Policy:

Mr. Warrick stated another item that came out of the audit was the requirement for the JEDZ to have a Public Records Policy. He requested a motion for the Northwest JEDZ to accept Sycamore Township's Public Records Policy.

Mr. Warrick answered he doesn't know but he thinks it is capped at a dollar amount. He said Ms. West will have to go back and take a look.

Mr. Lahrmer asked if Mr. Warrick will prepare a 2021 Budget.

Mr. Warrick answered yes saying he will have that in December.

Mr. Weidman asked if Mr. Moeller was seeing that in Madeira as well.

Mr. Moeller said the City of Madeira's earnings tax is down about 2% as of the end of July which is better than anticipated.

Mr. Weidman asked if there are any trouble spots in the East JEDZ District.

Mr. Moeller answered not that he is aware of

Mr. Weidman commented the numbers look good.

Mr. Moeller cautioned a lot 2020 collections but could be hanging on for dear life in 2021

Mr. Weidman said the nucleus of the JEDZ East District is office use. He said a suggestion was made at a previous meeting that there is concern about not being able to collect earnings tax from people working from home. He asked if Mr. Moeller is aware of legislation on that.

Mr. Moeller said there is legislation on that. He said the place of employment is still to collect earnings taxes, however, there are court cases going on currently trying to challenge that. He stated it could have an impact on JEDZ collections in the future.

There was continued discussion on the issue. Mr. Moeller said he will look into the status of the court case.

Budget:

Mr. Warrick reported per the audit the East JEDZ District must have an annual budget. He displayed the budget and asked Mr. Moeller if he had any changes to it.

Mr. Moeller said the budget is consistent with what we have been showing.

A motion to accept the 2020 budget was made by Mr. LaBarbara and seconded by Mr. Moeller. Mr. Warrick called roll. All Aye.

- Mr. Born said he is shocked it's higher than a year ago.
- Mr. LaBarbara commented Kenwood Towne Center is in this district.
- Mr. Moeller said yes Kenwood Towne Center and Kenwood Square.
- Mr. Weidman noted Kenwood Collection also. He said he is staggered by these numbers since Kenwood Towne Center was closed.
- Mr. Born noted if those businesses were paying employees with PPP that is still taxable.

Budget:

Mr. Warrick reported per the audit we need to have a JEDZ annual budget. He asked Mr. Moeller if he had any changes.

Mr. Moeller said it looks consistent.

A motion was made by Mr. Staubach to accept the 2020 budget and seconded by Mr. Born. Mr. Warrick called roll. All Aye.
