was substantially more than the fourth quarter distribution in 2019. She noted 2019 was not a great year and we are headed in the right direction. She said the numbers are very good considering the pandemic's negative effects on businesses; with the tax year figures for 2019 and 2020 being almost identical. The total distribution for the 2020 calendar year ended up with a total distribution of \$826,420.63 which was about \$72,000.00 less than 2019.

Mr. Weidman said that is still pretty good considering the pandemic. Mrs. Harcourt agreed.

Mr. Weidman asked if Amberley Village reciprocates and asked if she was aware of legislation regarding changes in earnings taxes for those working at home.

Ms. Harcourt answered yes and noted for Amberley Village, it would probably be in their best interest because a lot of their residents work in the City of Cincinnati.

Mr. Weidman said it would have a negative effect on the JEDZ. Mrs. Harcourt agreed.

Mr. Lahrmer said the SORTA sales tax in Hamilton County will have an effect on Amberley Village as well.

Mr. Muething spoke about the difference between withholdings and income tax. He asked if Bank of America has occupied the new building at the corner of Kenwood and Montgomery Roads and asked Mrs. Harcourt to make sure the businesses in the new building be made aware of the procedures to pay the JEDZ tax.

Mr. James requested the document Mr. Lahrmer shared be sent to the board members.

Mr. Warrick reported Kenwood Towne Center had said their 2020 sales were 85% overall of last year's sales with major high-end retailers showing an increase.
