Re: 2025 Sycamore Township Pavement Preservation Program

Dear Resident:

Sycamore Township is pleased to announce the improvements to **your street**. The project will consist of applying asphalt rejuvenation, "Reclamite", to the existing pavement. "Reclamite" is a Surface Treatment that seals, protects and enhances the pavement life.

The construction is scheduled to begin on **Tuesday, September 2 and be completed on Tuesday, September 9**. Please see the opposite side of this letter "Project Information Sheet" for the specific project information.

The roadway contractor, Pavement Technology, has been contracted by Sycamore Township to perform the necessary construction improvements.

Accordingly, we wish to advise that as with any type of construction, there will be some inconveniences in connection with this project. We regret any inconveniences that this work might cause you. All parties involved in this project will take all reasonable efforts to limit these inconveniences during the construction of the improvements.

You can assist in making the construction of the improvements a safe undertaking and in completing the work as quickly as possible by remembering the following:

- All construction sites can be dangerous. To avoid accidents, please keep children and pets away from all construction activities and construction equipment.
- When the work is scheduled for your street, the Contractor will notify you in advance, when the **"Street Work"** and **"No Parking"** will occur. Unfortunately, vehicles parked in areas other than those designated for parking **MAY BE TOWED** to allow construction to safely proceed.
- Please obey all "construction notifications" and the "posted traffic signs". They have been placed for the safety and protection of the public and the workers.

Sycamore Township has assigned an inspector to this project to oversee all aspects of construction and to assist the property owners. If at any time you feel that the contractor has not given proper attention to your property, or if you have any questions, please notify Mr. Mike Gould, Assistant Township Road Superintendent/ Project Manager at (513) 792-7251.

We are confident that you will find the enhancements to your neighborhood well worth any unavoidable inconveniences that you may encounter. We truly appreciate your cooperation and assistance!
