Project Description

Hamilton County is proposing improvements to the intersection of Fields Ertel Road and Conrey Road. Two options are being considered, which include a modern roundabout and a signalized intersection (see back of handout). The project will also include curb, drainage improvements, and resurfacing.

Purpose and Need

The purpose of the project is to reduce congestion at the Fields Ertel Road and Conrey Road intersection and to improve system linkage within Hamilton, Butler, and Warren Counties. A comparison of capacity analyses is below.

Funding

Hamilton County is the project sponsor. Funding has not yet been identified for this project.

Environmental Studies

An Environmental Overview was prepared for the project in October 2018 to identify key environmental resources and constraints in the study area. If federal funds end up being utilized, the project would need to follow ODOT procedures in accordance with the National Environmental Policy Act (NEPA).

Proposed Schedule

- Start of Design July 2018
- Public Open House April 2019
- Establish Preferred Alternative May 2019
- Stage 1 Design August 2019
- Stage 2/3 Design January 2020
- Final Design March 2020
- Anticipated Start of Construction TBD

Construction Traffic

The construction schedule for this project has not been determined yet. The maintenance of traffic plan will depend upon the alternative selected and may include a closure with detour.

Right-of-Way Purchase

Some new right-of-way may be needed for this project but has not been finalized yet. A right-of-way representative from Hamilton County will contact you as soon as definite information becomes available should the ultimate design of the project affect your property or lands.
