Project Description

Hamilton County is proposing improvements to the intersection of Fields Ertel Road and McCauly Road. Proposed improvements include construction of a 500' eastbound left turn lane on Fields Ertel Road, a 425' westbound right turn lane on Fields Ertel Road, a 375' southbound right turn lane on McCauly Road, and a span wire traffic signal installation. The project will also include drainage improvements and resurfacing.

Purpose and Need

The purpose of the project is to reduce congestion at the Fields Ertel Road and McCauly Road intersection. A comparison of capacity analyses is below.

Intersection Level of Service (LOS*) / Average Delay

2022 AM	F / 69.4 sec	C / 22.0 sec
2022 PM	F / 87.4 sec	C / 22.0 sec
2042 AM	F / 312.1 sec	D / 39.7 sec
2042 PM	F / 349.7 sec	C / 31.4 sec

*LOS Key: A = Free flow; B = Stable flow with slight delay; C = Stable flow with acceptable delay; D = Approaching unstable flow; E = Unstable flow; F = Congested with considerable delay



Funding

Hamilton County is the project sponsor. Funding has not yet been identified for this project.

Construction Traffic

Maintenance of traffic plans are being developed and will consist of lane closures and may possibly include a closure with detour.

Environmental Studies

An Environmental Overview was prepared for the project in October 2018 to identify key environmental resources and constraints in the study area. If federal funds end up being utilized, the project would need to follow ODOT procedures in accordance with the National Environmental Policy Act (NEPA).

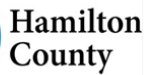
Proposed Schedule

Right-of-Way Purchase

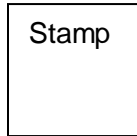
