## Fields Ertel Road Intersection Improvement Projects

The Hamilton County Engineer's Office (HCEO) invites you to an open house public meeting to learn about proposed improvements to the intersections of Fields Ertel Road and McCauly Road, Fields Ertel Road and Conrey Road, and Fields Ertel Road and Butler-Warren Road. Proposed improvements vary by intersection and may include traffic signal installations, roundabouts, new curb and gutter, and new storm drainage. The improvements will reduce congestion and delay at the intersections. Anticipated property impacts as well as construction funding and schedules are unknown at this time.

At the meeting, you will be able to review options and comment on the proposed projects. Representatives from the HCEO and the engineering consultants will be available throughout the open house to answer questions. Comment sheets and exhibits will be available during the open house. There will be no presentation and you may arrive anytime between 5 and 7 PM.
