While the spring flowers have sprung throughout the township, we have also experienced many other things springing up in Kenwood as we enter the summer season. We have been working very hard to revitalize the Kenwood Business District, and it was certainly apparent earlier this year when we had four cranes working at four separate Kenwood sites.

The Kenwood Collection, owned by Sycamore Township-based Phillips Edison, is now closing in on completion and it is everything we have waited for these many years. It will contain 275,000 square feet of Retail and 180,000 square feet of Class A office space. The office is close to being full and is scheduled to open in October, 2015. Phillips Edison has some big announcements on retail tenant commitments that will be announced very soon. The retail space opening is scheduled for Spring, 2016.

Directly across I-71 from The Collection is a new, 4-story building that will be the new home of Tri-Health. This building will house both Tri-Health medical staff as well as Administration.

If you come west on Galbraith Road to Kenwood Road, you will see the newest addition to the Jewish/ Mercy Medical Campus. This 6-story tower will house the redesigned Emergency Room, the Gamma Knife for Cancer treatment, and will replace the smaller patient rooms with larger, private rooms to meet the new trend in larger rooms to accommodate family stays, which promote faster healing for the patients.

Behind the Towers of Kenwood, and visible from the highway interchange, is the new Hampton Inn and Suites Hotel which has 125 rooms and is a welcome addition to Kenwood. The hotel is scheduled to open in late 2015.

These four projects add over \$250 Million of additional commercial value and tax base in Kenwood, which will continue to keep Sycamore Township with the lowest township taxes of any township in Hamilton County, and the only township that can say it has not had a levy on the ballot in the last 9 years.

If you've tried to navigate the Montgomery Road/Hosbrook Road intersection the last few months, it has been a real challenge, but that is coming to a quick end. Road improvements are about complete at that intersection, but the most noticeable thing you will see is the elimination of the utility poles along Montgomery Road from the highway north to Galbraith Road. In addition to road improvements on Galbraith Road, we have also added two additional circuits for improved power delivery, as well as system redundancy in the event that the first circuit fails. This will assure a more consistent and uninterrupted supply of electricity for both our Business District as well as our Kenwood residents.

Summer in Sycamore wouldn't be complete without the Annual Festival in Sycamore. This year it will be Friday and Saturday nights, July 17th and 18th at Bechtold Park. We are pleased to welcome Mark Farner, former lead singer of Grand Funk, on Friday night, and the legendary band KANSAS on Saturday night. This lineup may prove to be the best summer festival yet, so plan to be there.

As many of you enjoy vacations with your families this summer, we hope that your travels are safe and your experiences are unforgettable. As always, if there is anything that I can do to be of assistance, please don't hesitate to call me at the township offices.

SUMMER SAFETY TIPS: IDENTITY THEFT PREVENTION

April 15, Tax Day, a date many of us already dread every year, has become a reminder of an unfortunate fact of life in our digital age: Identity Theft. Your Sheriff's Office, along with law enforcement agencies nationwide, has seen a marked increase in the amount of fraudulent Federal and State income tax returns filed this year. There have been an unprecedented number of victims reporting rejected income tax returns due to the fact that their Social Security number has already been associated with a filed tax return. Members of the Sheriff's Office and the Township Administration have been victims as well.

Most of us already know the basics of protecting our identity: do not give out your Social Security number or other personal identifying information, shred or burn any paperwork with personal information on it, and physically secure and password protect your laptops, tablets, and other electronic devices to prevent theft or unauthorized access. Despite all these measures, sometimes your best efforts are in vain when a financial institution, retailer, or the numerous other entities that store your information are electronically hacked by sophisticated and well funded criminal parties.

So what can you do to safeguard your identity and prevent a fraudulent tax return in your name? First of all, get the returns done early. I know it pains many of us, but if you get yours in before the criminals can get their fraudulent returns in, the criminal will get the reject notice instead of you.

If you receive a notice from the IRS and/or the Ohio Department of Taxation, respond immediately, then call the Sheriff's Office so we can initiate a report for you. If you believe someone may have used your SSN illegally, please notify the IRS and the Ohio Department of Taxation as soon as possible. For the IRS, you must complete and submit the IRS Identity Theft Affidavit, Form 14039. For the Ohio Department of Taxation you must complete and submit a separate Identity Theft Affidavit. Additionally, you may call the IRS at 1-800-908-4490 and/or the Ohio Department of Taxation at 1-800-282-1780. You should also periodically monitor your credit report to ensure that there are no unauthorized credit lines opened or other suspicious activity.

SERVICES OFFERED BY YOUR FIRE DEPARTMENT

Infant / Child Car Seats

The Sycamore Township Fire Department can help you make sure you have your child's car seat installed correctly. According to the National Highway Traffic Safety Administration (NHTSA), three out of four car seats are improperly installed. Below are the most important factors when it comes to installing your car seat correctly:

Car seats for young babies should be installed in the rear-facing position in the center of the rear seat (or the center seat of a van or station wagon with more than one backseat). Keep your child in a rear-facing car seat for as long as possible, until age two is the recommendation, or when your child reaches the seat's maximum rear-facing height and weight limits.



Once your toddler outgrows the rear-facing capabilities of his car seat, he can ride facing forward. The middle of the backseat is still the safest place for a young child to sit.

If you need help with a car seat or are confused by the recommendations, call the Sycamore Township Fire Station at 792-8565 to reserve a time for us to assist you.



Can We Find You?

Address signs for your home can be custom made at the fire station. We also have a sign post available if you have no visible area on your home to place a sign or your home cannot be seen from the road. For the elderly, our firefighters will install your sign and post for you.

Cost: \$9 for the sign, \$14 for the sign and post. (Install included)

Blood Pressure Checks

The Sycamore Township Fire Department provides free routine blood pressure checks to the public at both fire stations seven days a week. We have special cards to record your pressure that you can carry with you for future comparisons and share with your doctor during your next appointment. If you are suffering from a medical emergency do not attempt to get to the station; you should call 911 so we can come to you.





Smoke Detectors

The Sycamore Township Fire Department provides free smoke detectors and batteries to our residents. Stop by the fire station for a new battery or smoke detector. If you are elderly or unable to get on a ladder, please do not attempt to change your battery. The firefighters will replace it for you. If you need assistance installing or knowing where to place your smoke detector, just call, we will be glad to help you.



PROPERTY MAINTENANCE CODE INFORMATION

Sycamore Township has a property maintenance code and all property owners are required to meet the minimum standards of that code for the public safety and welfare of the Township. This code applies to both residential and commercial properties and helps keep our community safe. Most Sycamore Township property owners take great pride in keeping their property in pristine condition but on occasion a property within the Township has been neglected or fallen into disrepair.

Please use one of the following options to report such concerns: Go to www.sycamoretownship.org and click on "Property Complaint Form" to enter a complaint online.

Call the Planning and Zoning Hotline at (513) 792-7279 to leave a message for the Code Enforcement Official.

You may leave your name and contact information or choose to remain anonymous. It is very important to have the correct address of the problem property and be as specific as possible regarding the complaint. The standard time to review complaints is within ten business days.

The Township does have authority to enforce compliance for the following issues:

- Tall grass/weeds
- Junk vehicles on private property
- Garbage/refuse and debris
- Boats/Trailers parked on residential property
- Dumpsters and material such as mulch, gravel and pavers left in our roadways

The following items are not enforceable by the Township and may be a civil matter between you and your neighbor:

- Dead or dying trees on private property
- Property line disputes
- Drainage issues such as natural drainage areas designed by the subdivision developer
- Vehicles parked in front of your residence on a public street

SYCAMORE TOWNSHIP RESIDENTS RECYCLED 885.09 TONS IN 2014

Congratulations Sycamore Township residents! In 2014, we recycled 885.09 tons of metal, glass, plastic and paper. Residents saved resources, conserved energy, and reduced pollution by recycling.

The recycling efforts in Sycamore Township:

- Conserved enough energy to power every home in Sycamore Township for 5 days.
- Reduced more air pollution than if every household member in Sycamore Township rode a bicycle to work for 4 weeks.
- Saved 7,330 trees from being harvested.

Recycling reduces pollution so the air we breathe is cleaner, conserves natural resources so we will have them to use in the future, and decreases the energy needed to make new products. Recycling also boosts our local economy by creating 169,000 jobs (4.3% of all jobs) just in the State of Ohio.

On average, each household in Sycamore Township recycled 214 pounds in 2014. That's 13.15% of all the waste we generate.
