The garage does meet the setback requirements in relation to all property lines

and other structures on the lot. The variance request is due to the fact that the garage is larger than the total accessory use for the property permitted as of right.

B2011-20V Rob Painter, P.E. 4120 Myrtle Avenue Cincinnati, OH 45236

Mr. Bickford presented the case and case history in a power point presentation. Mr. Bickford noted Section 12-4 of the Sycamore Township Zoning Resolution allows for eight ft. fences in commercial districts for vehicular storage. Although the church is located in a residential district, there is precedence there. Mr. Bickford stated that the applicant would be permitted to park the trailer on the church's property without the fence as of right, however, the church had requested the applicant screen the trailer for aesthetic and security reasons.

The Board asked questions of Mr. Bickford.

Mr. Eichmann asked if the applicant was present to address the board.

The applicant, Mr. Rob Painter, of 4333 Aaron Court, Cincinnati, OH 45241, addressed the board. Mr. Painter stated he is Assistant Scout Master for Troop #18 and is also an engineer for Kleingers and Associates. Mr. Painter stated that St. Saviour is Troop #18's sponsoring organization and that the church had agreed to allow the troop to park their trailer on church property provided it is screened. The trailer is 7.5 ft. tall and therefore would not be fully screened by a 6 ft. fence.

The board asked questions of the applicant.

Mr. Eichmann asked why the trailer and fence was at an angle as shown on the submitted site plan. Mr. Painter stated that angle was necessary to avoid blocking windows on the building, allow for an existing tree to remain and to allow for the trailer to be backed into the spot easily.

Mr. Eichmann asked if there was anyone present from the public who wished to comment on the case. No response. Mr. Eichmann closed the floor to comments and questions from the public.

The Board discussed the issues brought before them.

Mr. Eichmann made a motion to approve case# B2011-20V with the following condition:

1. In the event that the trailer is no longer stored on church property, the fence shall be removed.
