

LOCATION:

Cornell Road at Interstate 275 2.557 Acres

"OO" (PLANNED OFFICE DISTRICT)

Thence with said centerline, North 83°09'00" East, 200.00 feet to the northeast corner of a parcel of land conveyed to Le Roy T. and Julia M. Fleisch by deed recorded in Deed Book 3101, Page 220, Hamilton County, Ohio Recorder's Office;

Thence with the east line of said Fleisch, South 01°03'00" West, 331.54 feet to the point of beginning.
