RESOLUTION 2024 - 015

A RESOLUTION AUTHORIZING A CONTRACT FOR THE PURCHASE OF A 2024 SMITHCO SAND STAR 1 WITH INCLUDED OPTIONS AND THE DISPOSAL OF AN EXSTING 2007 SAND STAR AND DISPENSING WITH A SECOND READING

WHEREAS, the Board of Township Trustees has determined that the 2024 Smithco Sand Star 1 with included options is available from Baker Vehicle Systems, at an approximate discounted price of twenty (20) percent off MSRP for Townships and Municipalities; and

WHEREAS, the Board of Township Trustees wishes to purchase a 2024 Smithco Sand Star 1 with included options from Baker Vehicle Systems for use in the Township Maintenance department; and

WHEREAS, the Board of Township Trustees has followed the procedure as set forth in the Ohio Revised Code Section 9.17 for the selection of the Smithco Sand Star 1 with included options; and

WHEREAS, the Board of Township Trustees owns a 2007 Smithco Sand Star that is obsolete and unfit for public use and the Board desires to dispose of the unit; and

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township Administrator is hereby authorized to acquire the Smithco Sand Star 1 with included options from Baker Vehicle Systems in an amount not to exceed \$31,253.20.

SECTION 2. The Trustees of Sycamore Township hereby finds that the 2007 Smithco Sand Star currently owned by Sycamore Township is obsolete and unfit for public use. The Township Administrator and Township Road Superintendent are hereby authorized and directed to dispose of the unit in accordance with any method of disposal authorized by the Ohio Revised Code Section 505.10.

SECTION 3. The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 4. This resolution shall take effect on the earliest date allowed by law.




