A RESOLUTION AUTHORIZING A CONTRACT WITH CHOICE ONE ENGINEERING CORP. FOR ENGINEERING SERVICES FOR THE BAEN ROAD AND DEERFIELD ROAD SIDEWALK PROJECT, DISPENSING WITH A SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees is making improvements to construct a sidewalk on Baen Road and Deerfield Road in the Township (the "Baen Road and Deerfield Road Sidewalk Project") and wishes to provide for engineering services in regard to the project; and

WHEREAS, the Board of Township Trustees desires to contract for engineering services and has followed the procedure set forth in Ohio Revised Code for selection of an engineering firm for the Baen Road and Deerfield Road Sidewalk Project; and

WHEREAS, the Board of Trustees desires to proceed with the sidewalk improvements and to contract with Choice One Engineering Corp. for engineering services for the Baen Road and Deerfield Road Sidewalk Project;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The attached proposal from Choice One Engineering Corp. is hereby approved, and the Township Administrator is hereby authorized and directed to contract with Choice One Engineering Corp. to provide the engineering and survey services for the Baen Road and Deerfield Road Sidewalk Project.

SECTION 2.

The contract price for the design shall not exceed \$11,900.00.

SECTION 3.

The Board upon at least a majority vote does hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorizes the adoption of this Resolution upon its first reading.

SECTION 4.

Upon the unanimous vote of the Board of Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of Sycamore Township and shall take effect immediately. The reason for the emergency is the need to begin engineering on the project as soon as possible.


