RESOLUTION 2024 - 039

A RESOLUTION AUTHORIZING A CONTRACT FOR THE PURCHASE OF A 2024 CHEVROLET SILVERADO 4500 HD REGULAR CAB 4X2 WITH INCLUDED OPTIONS AND THE DISPOSAL OF AN EXISTING 2007 CHEVROLET SILVERADO 4500 HD REGULAR CAB 4X2 AND DISPENSING WITH A SECOND READING

WHEREAS, the Board of Township Trustees has determined that the 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 with included options is available from McCluskey Chevrolet, at a discounted price using the GM Municipal Discount; and

WHEREAS, the Board of Township Trustees wishes to purchase a 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 with included options from McCluskey Chevrolet for use in the Township Maintenance department; and

WHEREAS, the Board of Township Trustees has followed the procedure as set forth in the Ohio Revised Code Section 9.17 for the selection of the 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 with included options; and

WHEREAS, the Board of Township Trustees owns a 2007 Chevrolet Silverado 4500 HD Regular Cab 4x2 that is obsolete and unfit for public use and the Board desires to dispose of the unit; and

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township Administrator is hereby authorized to acquire the 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 with included options from McCluskey Chevrolet in an amount not to exceed \$59,497.00.

SECTION 2. The Trustees of Sycamore Township hereby finds that the 2007 Chevrolet Silverado 4500 HD Regular Cab 4x2 currently owned by Sycamore Township is obsolete and unfit for public use. The Township Administrator and Township Road Superintendent are hereby authorized and directed to dispose of the unit in accordance with any method of disposal authorized by the Ohio Revised Code Section 505.10.

SECTION 3. The Board of Trustees of Sycamore Township upon at least two-third vote of all its members, dispenses with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


SECTION 4.

This resolution shall take effect on the earliest date allowed by law.






