RESOLUTION 2024 - 040

**A RESOLUTION AUTHORIZING A CONTRACT FOR THE PURCHASE OF A TRUCK BED FOR A 2024 CHEVROLET SILVERADO 4500 HD REGULAR CAB 4X2 AND DISPENSING WITH A SECOND READING**

**WHEREAS**, the Board of Township Trustees has determined that the Truck Bed for a 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 is available from Big Tex Trailer World, Inc., at an approximate discounted price of thirty (30) percent off MSRP for Townships and Municipalities; and

**WHEREAS**, the Board of Township Trustees wishes to purchase a Truck Bed for a 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 from Big Tex Trailer World, Inc., for use in the Township Maintenance department; and

**WHEREAS**, the Board of Township Trustees has followed the procedure as set forth in the Ohio Revised Code Section 9.17 for the selection of the Truck Bed; and

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The Township Administrator is hereby authorized to acquire the Truck Bed for a 2024 Chevrolet Silverado 4500 HD Regular Cab 4x2 from Big Tex Trailer World, Inc., in an amount not to exceed \$11,175.00.

**SECTION 2.** The Board of Trustees of Sycamore Township, by at least two-third vote of all its members, dispenses with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 3.** This resolution shall take effect on the earliest date allowed by law.


