

RESOLUTION 2024- 087

**A RESOLUTION AUTHORIZING A CONTRACT FOR THE SIDEWALK REPAIR PROGRAM, DISPENSING WITH A SECOND READING, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Board of Township Trustees is desirous of making improvements and repairs to sidewalks in the Township on the following streets: Wetherfield Lane, Westover Circle, Sturbridge Drive, Pepperell Lane, Stoneham Place and Branford Court (the “Sidewalk Repair Program”); and

**WHEREAS**, the Township prepared specifications for the Sidewalk Repair Program and has followed the procedure set forth in Ohio Revised Code for selection of a contractor for the Sidewalk Repair Program; and

**WHEREAS**, Adleta Construction submitted a proposal of \$16.25 a square foot (S.F.) in accordance with the specifications prepared by the Township; and

**WHEREAS**, the Board of Trustees desires to proceed with the sidewalk repairs and to contract with Adleta Construction for construction services for the Sidewalk Repair Program;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The attached proposal from Adleta Construction for the Sidewalk Repair Program is hereby approved and the Township Administrator is hereby authorized and directed to contract with Adleta Construction for the Sidewalk Repair Program as set forth in the specifications prepared by the Township for the project.

**SECTION 2.** Such contract shall provide that Adleta Construction shall provide and furnish all the labor, materials, tools, expendable equipment, and all utility, insurance and transportation services required in accordance with the specifications prepared by the Township, which specifications shall be made a part of such contract.

**SECTION 3.** Subject to additions and deletions contained therein, the contract price shall not exceed \$72,491.25.

**SECTION 4.** The Trustees of Sycamore Township upon majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 5.** Upon the unanimous vote of the Board of Township Trustees, this

Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of Sycamore Township and shall take effect immediately. The reason for the emergency is the need to begin construction on the project as soon as possible.

**SECTION 6.** This Resolution shall take effect on the earliest date allowed by law.
