RESOLUTION NO. 2011 - 24

**A RESOLUTION DENYING A MAJOR MODIFICATION AND SITE PLAN FOR
THE SALONS @ KENWOOD IN THE MIDLAND ATLANTIC DEVELOPMENT
AND DISPENSING WITH THE SECOND READING**

WHEREAS, on April 11, 2011, after proper notice having been given, the Sycamore Township Zoning Commission held a public hearing to consider the application of KAP Signs (the "Applicant") for a proposed major adjustment to a prior PUD approval in Sycamore Township (the "Application"); and

WHEREAS, the Application in Case No. 2011-03MA, known as the Midland Atlantic Real Estate Development, includes the real property located at 7855 Kenwood Road in Sycamore Township and consists of Hamilton County Auditor's Parcel Number 600-0210-0861-00 (the "Real Property");

WHEREAS, the property owners submitted plans and specifications in Case No. 2011-03MA and

WHEREAS, the Application is a request to install additional signage on the building; and

WHEREAS, on April 11, 2011, the Sycamore Township Zoning Commission recommended denial of the Application: and

WHEREAS, on May 5, 2011, after proper notice having been given, the Board of Township Trustees of Sycamore Township held a public hearing to consider the proposed Major Adjustment contained within the Application and the plans and specifications submitted; and

WHEREAS, upon conclusion of the public hearing, the Board of Township Trustees of Sycamore Township considered, in an open meeting, the proposed major adjustment to the planned unit development and the recommendation of the Sycamore Township Zoning Commission in Case No. 2011-03MA;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. That the recommendation of the Sycamore Township Zoning Commission in Case No. 2011-03MA is hereby approved and the major adjustment to the planned unit development as requested in the Application is denied.

SECTION 2.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


