A RESOLUTION RECONCILING BUDGETS AND APPROPRIATIONS, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, in order to reconcile budgets and appropriations for calendar year 2008;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Kenwood Tax Increment Improvement Fund – Debt Service Payment line shall be \$585,535.00. This constitutes an increase of \$585,535.00.

SECTION 2.

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Sycamore Financial/Redstone Tax Increment Fund – Debt Service Payment Redstone Bonds line shall be \$170,145.00. This constitutes an increase of \$170,145.00.

SECTION 3.

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Kenwood Crossings Tax Increment Fund – Contract Kenwood Crossings 1 line shall be \$100,000.00. This constitutes an increase of \$50,000.00.

SECTION 4.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 5.

This resolution shall take effect on the earliest date allowed by law.

SECTION 6.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to provide for the immediate reconciliation of budgets and appropriations for calendar year 2008.
