# A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR CERTAIN TOWNSHIP EMPLOYEES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, Resolution 2008-119 establishing a rate of pay for 2009 for township employees contained a two clerical errors that the Board wishes to correct;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1**.

The portion of Section 3 of Resolution 2008-119 which reads as follows:

is deleted in its entirety. In its place is substituted as follows:

SECTION. 2

All other provisions of Resolution 2008-119 not amended herein shall

remain in full force and effect.

**SECTION 3.** 

This amendment is in keeping with the collective bargaining agreement

between the township and its firefighter's union.

**SECTION 4.** 

The Trustees of Sycamore Township, upon at least a majority vote, dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first

reading.

SECTION 5.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide wages in a timely manner to Township employees.
