RESOLUTION NO. 2009 - 129

A RESOLUTION APPROVING A MAJOR ADJUSTMENT TO A SITE PLAN FOR THE SHOPPES OF KENWOOD REAL ESTATE DEVELOPMENT, AND DISPENSING WITH THE SECOND READING

WHEREAS, application was made by Kenwood Shoppes LLC/Neyer Holdings (the "Owner-Receiver") for approval of a site plan to allow Gordon Food Services to open a food sales operation in the Shoppes of Kenwood Real Estate Development in Case Number 2009-10MA; and

WHEREAS, on August 10, 2009 and September 14, 2009, after proper notice having been given, the Sycamore Township Zoning Commission held public hearings to consider the application for approval of a major adjustment for the Shoppes of Kenwood Real Estate Development in Case Number 2009-10MA; and

WHEREAS, the real property in Case No. 2009-10MA, consists of the real property located at 7700 Montgomery Road in Sycamore Township and is designated as Hamilton County Auditor's Parcel Number 600-0211-0543-00 (the "Real Property");

WHEREAS, the Real Property is located in the "EE"- Retail District with a Planned Unit Development (PUD) overlay; and

WHEREAS, previous approvals for the development limited the operations of food service businesses in the Shoppes of Kenwood Real Estate Development; and

WHEREAS, the Applicant, Gordon Food Services desires to open a food service establishment on the Real Property; and

WHEREAS, on September 14, 2009 in a public hearing and an open meeting, the Sycamore Township Zoning Commission recommended approval of the application with certain conditions and communicated its recommendation to the Board of Township Trustees on September 30, 2009; and

WHEREAS, on October 13, 2009, after proper notice having been given, the Board of Township Trustees of Sycamore Township held a public hearing to consider the application for the major adjustment to the planned unit development;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The Application of Gordon Food Services to operate a food service business in the Shoppes of Kenwood Real Estate Development is hereby approved. This approval is subject to the conditions set forth on the attached Exhibit A as if fully rewritten herein.

SECTION 2.

All other approvals, conditions, obligations and requirements contained in previous approval of the development not adjusted herein shall remain in full force and affect. This resolution shall only consider the approval of the operations of Gordon Food Services.

SECTION 3.

Any use and improvements made to the Real Property which is the subject of this Resolution shall be constructed in compliance with the plans, specifications, and renderings submitted and approved by this Resolution, and any previous resolutions in effect that affect the Real Property.

SECTION 4.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
