A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR A TOWNSHIP EMPLOYEE, DISPENSING WITH THE SECOND READING AND DECLARING AN **EMERGENCY**

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

Effective November 15, 2009, the following employee shall be compensated at an annual rate set opposite his name:

Jason Petty

\$15.00 per hour, plus uniforms

This rate of pay shall be paid in accordance with the regular pay schedule of the township on and after the effective date. In addition, the employee shall receive all other benefits as provided to full time employees under the Sycamore Township employee handbook.

SECTION 2.

The line of Section 2 of Resolution 2009-89 which reads:

"Jason Petty

\$13.00/hour plus uniforms"

is deleted in its entirety.

SECTION 3.

The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

SECTION 4.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide wages in a timely manner to Township employees.
