Both of the above parcels are to be included within Resolution 2008-89 as if they had been included in the original Resolution 2008-89 passed October 14, 2008

SECTION 2.

All other provisions contained within Resolution 2008-89 not amended herein shall remain in full force and effect.

SECTION 3.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 4.

This resolution shall take effect on the earliest date allowed by law.
