RESOLUTION NO. 2009-170

A RESOLUTION ESTABLISHING RATES OF PAY AND BENEFITS FOR TOWNSHIP EMPLOYEES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, in order to establish rates of pay and benefits for employees of Sycamore Township beginning December 27, 2009;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. All full-time employees of Sycamore Township shall receive medical, dental, and life insurance benefits, vacation time, sick days, and personal days as established in the Employee Handbook for 2010.


SECTION 5.
