All other provisions of Resolution 2008-119 not amended herein and all previous amendments of Resolution 2008-119 shall remain in full force and effect.

#### **SECTION 3.**

This amendment is in keeping with the collective bargaining agreement between the township and its firefighter's union.

#### **SECTION 4.**

The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.
