A RESOLUTION AUTHORIZING A CONTRACT FOR 2009 ROAD IMPROVEMENT PROJECT, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees is desirous of making improvements to the various roads in the in the Township (the "2009 ROAD IMPROVEMENT PROJECT"); and

WHEREAS, the Township caused plans and specifications for the 2009 ROAD IMPROVEMENT PROJECT to be prepared and advertised for bids as required by state law; and

WHEREAS, John R. Jurgenson Co. submitted the lowest and best bid for the 2009 ROAD IMPROVEMENT PROJECT in the amount of \$1,367,251.95;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The President of the Board and Fiscal Officer are hereby authorized and directed to contract with John R. Jurgenson Co. to provide for the 2009 ROAD IMPROVEMENT PROJECT as set forth in the plans and specifications prepared by the Township for the project.

SECTION 2.

The contract with John R. Jurgenson Co. shall provide that the contractor shall provide and furnish all of the labor, materials, tools, expendable equipment, and all utility, insurance and transportation services required in accordance with the plans and specifications prepared by the Township for the 2009 ROAD IMPROVEMENT PROJECT, which plans and specifications shall be made a part of such contract.

SECTION 3.

Subject to additions and deletions contained therein, the contract price with Barrett Paving Materials, Inc.. shall not exceed \$1,367,251.95.

SECTION 4.

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all of its members, dispenses with the requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.

SECTION 5.

This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Sycamore Township. The reason for the emergency is to immediately provide for safe roads and streets in Sycamore Township
