RESOLUTION 2009-94

A RESOLUTION AUTHORIZING A CONTRACT FOR ASPHALT REPAIRS IN THE DEERFIELD ROAD PARK, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees is desirous of making repairs to the asphalt in the park on Deerfield Road in the Township (the "DEERFIELD ROAD PARK ASPHALT REPAIR PROJECT");

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The attached contract with Blue Chip Pavement Maintenance, Inc is hereby approved and the President of the Board and Fiscal Officer are hereby authorized and directed to execute the contract with Blue Chip Pavement Maintenance, Inc. to provide for the Deerfield Road Park Asphalt Repair Project.

SECTION 2. Subject to additions and deletions contained therein, the contract price shall not exceed \$23,054.00.


SECTION 3. The Board of Township Trustees of Sycamore Township, by at least two-third vote of all of its members, dispenses with the requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.

SECTION 4. This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Sycamore Township. The reason for the emergency is to immediately prevent the further deterioration of the asphalt in the Deerfield Road park.






