# A RESOLUTION RECONCILING BUDGETS AND APPROPRIATIONS, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, in order to reconcile budgets and appropriations for calendar year 2010;

**NOW THEREFORE, BE IT RESOLVED,** by the Board of Township Trustees of Sycamore Township, State of Ohio:

# SECTION 1.

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Gasoline Tax Fund - Tools and Equipment Line shall be \$150,000.00. This constitutes a decrease of \$150,000.00.

#### **SECTION 2.**

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Permissive Motor Vehicle Tax Fund – Tools and Equipment Line shall be \$80,000.00. This constitutes a decrease of \$120,000.00.

#### **SECTION 3.**

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Karrington Tax Increment Equivalent Fund – Contracts line shall be \$200,000.00. This constitutes a decrease of \$300,000.00.

#### **SECTION 4.**

The Fiscal Officer of the Township is hereby authorized and directed to transfer the sum of \$150,000.00 from the General Fund – Transfers Out line to the Deerfield Park Project Fund – Deerfield Park Project Expenses line the sum of \$150,000.00.

#### **SECTION 5.**

The Fiscal Officer of the Township is hereby authorized and directed to transfer the sum of \$100,000 from the General Fund – Transfers Out line to the Sturbridge Project Fund – Sturbridge Project Expenses line the sum of \$100,000.00.

#### **SECTION 6.**

The Fiscal Officer of the Township is hereby authorized and directed to transfer the sum of \$105,000 from the General Fund – Transfers Out line to the Station 93 Project Fund – Station 93 Project Expenses the sum of \$105,000.00.

#### SECTION 7.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

### **SECTION 8.**

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to provide for the immediate reconciliation of budgets and appropriations for calendar year 2010.
