RESOLUTION 2010- 14

**RESOLUTION PROVIDING FOR AND AUTHORIZING REMOVAL OF TRASH AND DEBRIS,
DECLARING A NUISANCE FOR THE RIGHT-OF-WAY IN FRONT OF THE PROPERTY LOCATED
AT 11987 FOURTH AVENUE, DISPENSING WITH THE SECOND READING
AND DECLARING AN EMERGENCY**

WHEREAS, Ohio Revised Code §505.87 provides that a Board of Township Trustees may provide for the abatement and control over the removal of trash and debris from land located in the Township; and

WHEREAS, the Board of Township Trustees of Sycamore Township has determined the unattended trash and debris located in the right-of-way in front of the property located at 11987 Fourth Avenue, Sycamore Township, Ohio 45249, is a nuisance;

NOW THEREFORE, Be It Resolved by the Board of Township Trustees, Sycamore Township, Ohio:

Section 1. That the unattended trash and debris located in the right-of-way in front of the property at 11987 Fourth Avenue, Sycamore Township, Ohio 45249, is hereby declared to be a nuisance.

Section 2. The maintenance department of the Township is hereby directed to remove and discard the unattended trash and debris located in the right-of-way in front of the property located at 11987 Fourth Avenue, Sycamore Township, Ohio 45249.

Section 3. The Trustees of Sycamore Township upon majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

Section 4. This Resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and welfare of the Township. The reason for the emergency is to provide for safe and habitable properties in the township.


