

RESOLUTION NO. 2010 - 34

**A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR CERTAIN  
TOWNSHIP EMPLOYEES**

**WHEREAS**, Resolution 2010-26 established rates of pay for 2010 for township employees; and

**WHEREAS**, Resolution 2010-26 contained a typographical error in the rate of pay for township employee Michael McKeown which the Board desires to correct;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Effective with the pay period beginning May 17, 2010, the following employee shall be compensated at an annual rate set opposite his name:

Michael McKeown                      \$50,000.00

Michael McKeown shall be entitled to other township benefits in accordance with the Sycamore Township Employee Manual.

**SECTION. 2**                      Section 3 of Resolution 2010-26 which reads:

“**SECTION 3.**                      Effective with the pay period beginning May 17, 2010, the following employee shall be compensated at the amount set opposite his name:

Michael McKeown                      \$55,000.00/year

Michael McKeown shall be entitled to other township benefits in accordance with the Sycamore Township Employee Manual.”

is hereby deleted in its entirety.

**SECTION 3.**                      All other provision of Resolution 2010-26 not amended herein shall remain in full force and effect.

**SECTION 4.**                      The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

**SECTION 5.**

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide the correct wages and benefits in a timely manner to a Township employee.


