	Sycamore Center Tax Increment Equivalent Fund – Contracts Line shall
	be \$600,000.00. This constitutes an increase of \$100,000.00.

SECTION 3.	The Fiscal Officer of the Township is hereby authorized and directed to
	amend the appropriations such that the annual appropriation for the
	Sycamore Commons Tax Increment Equivalent Fund – Contracts line
	shall be \$130,000.00. This constitutes an increase of \$100,000.00.

SECTION 4.	The Fiscal Officer of the Township is hereby authorized and directed to
	amend the appropriations such that the annual appropriation for the
	Kemper/Goldcoast/Deerfield Tax Increment Equivalent Fund – Contracts
	line shall be \$400,000.00. This constitutes an increase of \$400,000.00.

SECTION 5.	The Fiscal Officer of the Township is hereby authorized and directed to
	amend the appropriations such that the annual appropriation for the
	Kenwood Towne Place Tax Increment Equivalent Fund - Contracts line
	shall be \$436,135.27. This constitutes an increase of \$436,135.27.

SECTION 6.	The Fiscal Officer of the Township is hereby authorized and directed to
	amend the appropriations such that the annual appropriation for the
	Kenwood Towne Place Tax Increment Equivalent Fund – Other line shall
	be \$6029.90. This constitutes an increase of \$6029.90.

SECTION 7. The Fiscal Officer of the Township is hereby authorized and directed to

amend the appropriations such that the annual appropriation for the Cornell Snider Office Project Tax Increment Equivalent Fund – Contracts line shall be \$140,000.00. This constitutes an increase of \$140,000.00.

SECTION 8.

The Fiscal Officer of the Township is hereby authorized and directed to amend the appropriations such that the annual appropriation for the Brookwood Office Development Tax Increment Equivalent Fund – Contracts line shall be \$25,000.00. This constitutes an increase of \$25,000.00.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 9.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to provide for the immediate reconciliation of budgets and appropriations for calendar year 2010.
