# A RESOLUTION ADOPTING ADDITIONAL RULES AND REGULATIONS FOR THE USE OF PARKS IN SYCAMORE TOWNSHIP, DISPENDING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code Section 505.261 gives a board of township trustees authority to establish rules and regulations in township parks and to establish penalties for the violation thereof; and

**WHEREAS**, on November 5, 2009 by Resolution No. 2009 – 139, the Board of Township Trustees of Sycamore Township previously adopted, amended, and restated in their entirety the rules and regulation for the use of parks in Sycamore Township; and

WHEREAS, the Board wishes to adopt additional rules and regulations for the use of township parks in Sycamore Township;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

## SECTION 1.

Pursuant to Ohio Revised code Section 505.261, the rules and regulations adopted by the Board of Township Trustees as the established Rules and Regulations in Sycamore Township parks are hereby amended as follows:

Section 11 entitled "Parking" shall be amended to include the following paragraph:

"No person shall park or store any commercial car or truck, trailer, semi-trailer, pole trailer, bus, recreational vehicle, boat, watercraft, commercial tractor, or any other vehicle with a gross vehicle weight over 6,000 pounds in any township park unless prior permission from the Township is obtained."

#### **SECTION 2.**

Any person violating this Resolution and the parking prohibition contained herein shall be subject to the same fines and penalties as contained in the Park Rules and Regulations adopted and restated on November 5, 2009.

#### SECTION 3.

The Trustees of Sycamore Township upon majority vote do hereby dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

# **SECTION 4.**

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township. The reason for the emergency is to protect citizens and property and maintain safety in the parks in Sycamore Township.
