## RESOLUTION PROVIDING FOR AND AUTHORIZING REMOVAL OF TRASH AND DEBRIS, DECLARING A NUISANCE FOR THE PROPERTY LOCATED AT 4516 KUGLER MILL ROAD, SYCAMORE TOWNSHIP, OH 45236

- Section 1. That the trash and debris located on the property at 4516 KUGLER MILL ROAD, SYCAMORE TOWNSHIP, OH 45236, Auditor's Parcel Number: 060002020282 is hereby declared to be a nuisance.
- Section 2. Pursuant to O.R.C. §505.87, the owners and lien holders of record for the property shall be properly notified of this action and given seven days to abate the nuisance.
- Section 3. In the event the nuisance is not abated within the time period allowed, the maintenance department of the Township is hereby directed to remove and discard the unattended trash and debris at the property located at 4516 KUGLER MILL ROAD, SYCAMORE TOWNSHIP, OH 45236, Auditor's Parcel Number: 060002020282 and Sycamore Township Control Number SYCC120309.
- Section 4. The owner of the property at 4516 KUGLER MILL ROAD, SYCAMORE TOWNSHIP, OH 45236, Auditor's Parcel Number: 060002020282 shall be billed for such services and the Fiscal Officer shall place a special assessment on the real estate tax bill of the property if payment is not made within thirty days.
