RESOLUTION NO. 2012 - 47

A RESOLUTION RECOMMENDING AN AMENDMENT TO THE SYCAMORE TOWNSHIP ZONING RESOLUTION PROHIBITING ON STREET PARKING

WHEREAS, the Board of Township Trustees of Sycamore Township, Ohio desires to recommend an amendment to the Sycamore Township Zoning Resolution for the purpose of regulating on-street parking within the Township; and

WHEREAS, Ohio Revised Code Section 519.12 requires that the Board of Township Trustees adopt a resolution in order to request that the Township Zoning Commission consider an amendment to the Township Zoning Resolution;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

That the Board of Township Trustees recommends that the Sycamore Township Zoning Commissioner consider the following Amendment to the Sycamore Township Zoning Resolution: That the following section be added under Section 12-5 *Location of Required Parking Spaces:*

12-5.6 On Street Parking by Businesses Prohibited

All vehicles in the inventory of, being repaired by, worked on by, under the control of, or otherwise owned or maintained by any business located in Sycamore Township, Ohio or the employees of such business shall be parked or stored on the premises of such business and in an approved parking lot and in the required parking places for such business. Such vehicles shall not be parked for any period of time on the public streets or roadways of Sycamore Township or on the premises of another business within Sycamore Township, without the express permission of such other business. A vehicle shall be considered under the control of a business when the business, or its owner, or any employee of the business has physical control of the vehicle through the use of the keys to the vehicle or if the owner of the vehicle has placed the vehicle in the care of the business.

SECTION 2.

By majority vote of its members, the Board dispenses with any requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

SECTION 3.

This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the peace, health and safety of Sycamore Township. The reason for the emergency is the timely consideration of the Zoning Amendment by various reviewing committees.
