A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR CERTAIN TOWNSHIP EMPLOYEES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY

WHEREAS, Resolution 2011-125 established the rates of pay for township employees effective December 25, 2011; and

WHEREAS, the Board wishes to provide for new pay rates for EMS and Fire Department personnel as a result of a new contract with IFF Local 3907 and a reduction in the Fire Fund Budget.

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The portion of Section 2 of Resolution 2011-125 which reads as follows:

Part-time EMS/Fire Department personnel shall be compensated as follows:

Probationary EMT/FF shall be paid \$11.74 per hour, plus uniforms; Probationary Medic/FF shall be paid \$12.80 per hour, plus uniforms;

EMT/FF with more than one but less than four years of longevity with the Department shall be paid \$13.63 per hour, plus uniforms;

Medic/FF with more than one but less than four years of longevity with the Department shall be paid \$14.75 per hour, plus uniforms;

EMT/FF with at least four but less than six years of longevity with the Department shall be paid \$13.83 per hour, plus uniforms;

Medic/FF with at least four but less than six years of longevity with the Department shall be paid \$14.97 per hour, plus uniforms;

EMT/FF with at least six but less than eleven years of longevity with the Department shall be paid \$14.10 per hour, plus uniforms;

Medic/FF with at least six but less than eleven years of longevity with the Department shall be paid \$15.26 per hour, plus uniforms;

EMT/FF with at least eleven but less than fifteen years of longevity with the Department shall be paid \$14.37 per hour, plus uniforms;

Medic/FF with at least eleven but less than fifteen years of longevity with the Department shall be paid \$15.55 per hour, plus uniforms;

EMT/FF with fifteen or more years of longevity with the Department shall be paid \$14.64 per hour, plus uniforms;

Medic/FF with fifteen or more years of longevity with the Department shall be paid \$15.85 per hour, plus uniforms;

These rates of pay shall be paid in accordance with the regular pay schedule of the township on and after the effective date. For the purpose of determining an employee's longevity with the Department, years of longevity shall be measured from the employee's date of hire. When an employee moves into a new pay rate because of the passage of an employee's anniversary date with the Township, the new pay rate shall commence at the first regularly scheduled payroll period after the anniversary date.

SECTION 3.

These new rates of pay shall be effective August 19, 2012.

SECTION 4.

All other provisions of Resolution 2011-125 not amended herein shall remain in full force and effect.

SECTION 5.

The Trustees of Sycamore Township, upon at least a majority vote, dispense with the requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

SECTION 6.

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide wages in a timely manner to Township employees under the new fire department rates.
