In the event the nuisance is not abated within the time period allowed, the maintenance depa of the Township is hereby directed to remove and discard the unattended trash and debris at property located at 8559 KENWOOD ROAD, SYCAMORE TOWNSHIP, OH 45236, Auditor's Parcel Number: 060002020237 and Sycamore Township Control Number SYCC120407.
- Section 4. The owner of the property at 8559 KENWOOD ROAD, SYCAMORE TOWNSHIP, OH 45236, Auditor's Parcel Number: 060002020237 shall be billed for such services and the Fis Officer shall place a special assessment on the real estate tax bill of the property if payment made within thirty days.
- Section 5. The Trustees of Sycamore Township upon majority vote do hereby dispense with the require that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.
