- 3. As the above building location is under control of a tax-supported authority under Ohio law, the necessary space is provided without charge for the purpose of holding elections.
- 4. The space is to be used for election purposes as referred to in Item 1; shall be vacated by the Lessor on the date(s) and time(s) specified in Item 2; the Lessor may not change the designated space within 30 days prior to the election and the space must be such as to provide a barrier free site pursuant to law. If, during the term of the contract, there are ownership changes, the Board of Elections must be contacted immediately.
- 5. Lessor agrees to receive election equipment during the five (5) day period before the election and to store the equipment in a safe location up to seven (7) days after the election.
- 6. Lessor agrees to furnish the necessary and adequate light (including parking lot lighting), heat (minimum 72 degrees F February and November), and use of telephones, 2 tables and 8 chairs per precinct for use in the designated space. Access to restrooms is required.
- 7. The government of Hamilton County, Ohio is a self insured public entity as authorized by the ORC 2744.08. The County does not carry General Liability insurance, but funds its liabilities out of public funds.
