

RESOLUTION NO. 2015 - 22

A RESOLUTION AUTHORIZING AND DIRECTING TRANSFERS OF FUNDS TO RECONCILE BUDGETS AND APPROPRIATIONS, AND DISPENSING WITH THE SECOND READING

WHEREAS, in order to reconcile budgets and appropriations for calendar year 2015;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Motor Vehicle Fund the sum of \$1,600.00.

SECTION 2. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Motor Vehicle Fund the sum of \$1,600.00.

SECTION 3. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Road and Bridge Fund the sum of \$150,494.00.

SECTION 4. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Road and Bridge Fund the sum of \$150,494.00.

SECTION 5. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Permissive Motor Vehicle Tax Fund the sum of \$468,900.00.

SECTION 6. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Permissive Motor Vehicle Tax Fund the sum of \$468,900.00.

SECTION 7. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Police Fund the sum of \$50,000.00.

SECTION 8. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Police Fund the sum of \$50,000.00.

SECTION 9. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Fire and EMS Fund the sum of \$100,000.00.

SECTION 10.

The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Fire and EMS Fund the sum of \$100,000.00.

SECTION 11.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 12.

This Resolution shall take effect on the earliest date allowed by law.




