### SECOND AMENDMENT TO LEASE

This SECOND AMENDMENT TO LEASE is made as of the 1st day of April, 2015 by and between the Board of Township Trustees of Sycamore Township, Ohio, an Ohio township ("Lessor") and RGT Foods, Inc., a Mississippi corporation ("Lessee").

#### RECITALS:

WHEREAS, by Lease Agreement dated the 19<sup>th</sup> of September, 2011, (the "Lease Agreement"), Lessor did lease to RGT Foods, Inc. the property described as the "Demised Premises" located at 7781 Montgomery Rd., Cincinnati, OH 45236 (the "Property"); and

WHEREAS, the parties hereto desire to amend the Lease.

NOW, THEREFORE, in consideration of the Lease Agreement and the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is mutually agreed upon as follows:
