RESOLUTION 2016 - 50

A RESOLUTION DESIGNATING NO PARKING ON STREETS AND ROADS IN SYCAMORE TOWNSHIP, AND DISPENSING WITH SECOND READING

WHEREAS, in order to provide for safe streets and roads in Sycamore Township, Ohio;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Happiness Way, a dedicated road in Sycamore Township, there shall be no parking on the south side of Happiness Way from the intersection of Happiness Way and Festive Court to the intersection of Happiness Way and Kenwood Road.

SECTION 2.

Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Donna Lane, a dedicated road in Sycamore Township, there shall be no parking on the west side of Donna Lane from the intersection of Donna Lane and Estermarie Drive extending south a distance of 120 feet.

SECTION 3.

Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Estermarie Drive, a dedicated road in Sycamore Township, there shall be no parking on the south side of Estermarie Drive from the intersection of Estermarie and Donna Lane to the intersection of Donna Lane and Mantell Avenue.

SECTION 4.

Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Estermarie Drive, a dedicated road in Sycamore Township, there shall be no parking on the north side of Estermarie Drive from the intersection of Estermarie Drive and Donna Lane extending west a distance of 185 feet.

SECTION 5.

The Township Maintenance Department shall install the appropriate signage as required by law to enforce this Resolution.

SECTION 6.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

SECTION 7.

This Resolution shall take effect at the earlies possible date allowed by law.
