

**RESOLUTION NO. 2017 - 149**

**A RESOLUTION CORRECTING SCRIVENER'S ERRORS, AND DISPENSING WITH  
THE SECOND READING**

**WHEREAS**, on October 19, 2017, the Board of Township Trustees passed resolution 2017-117 extending the Quantum Chemical Corporation Tax Increment Financing exemption (the "Quantum TIF") for an additional fifteen years; and

**WHEREAS**, Resolution 2017-117 contains a scrivener's error in that it refers to the school district involved as the Indian Hill Exempted Village School District when in fact the correct school district for reference is the Princeton City School District; and

**WHEREAS**, in the approval of Resolution 2017-17 and the procedures leading up to its passage, the Princeton City School District was properly notified, the Princeton City School District has approved the extension of the Quantum TIF, and Sycamore Township has entered into a school district compensation agreement with the Princeton City School District to reimburse the district for revenues foregone because of the Quantum TIF extension; and

**WHEREAS**, the Board of Township Trustees wishes to pass this Resolution in order to correct the scrivener's error and indicate that the proper school District in the matter is the Princeton City School District;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** In order to correct a scrivener's error in Resolution 2017-117, in the fifth "WHEREAS" clause the words Indian Hill Exempted Village School District are hereby deleted and the words "Princeton City School District" are substituted in their place. In order to correct a scrivener's error in Resolution 2017-117, in SECTION 2, the words Indian Hill Exempted Village School District are hereby deleted and the words "Princeton City School District" are substituted in their place.


**SECTION 2.** The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


**SECTION 3.** This resolution shall take effect on the earliest date allowed by law.




