**RESOLUTION NO. 2018 - 124**

**A RESOLUTION APPROVING A MAJOR ADJUSTMENT TO AN APPROVED  
LOCALIZED AREA SIGN REGULATION PLAN IN KENWOOD SQUARE  
LOCATED IN THE KENWOOD SPECIAL PUBLIC INTEREST DISTRICT AND  
DISPENSING WITH A SECOND READING**

**WHEREAS**, application was made by Atlantic Sign Company (the "Applicant") on behalf of BRE DDR Crocodile Sycamore (the "Owner") for approval of a major adjustment to a Localized Area Sign Regulation ("LASR") Plan for the development known as the Firestone Building in Kenwood Square (formerly known as Sycamore Plaza) to change outdoor signage on the building for the real property located at 7800 Montgomery Road Unit 17, Sycamore Township, Hamilton County, Ohio (the "Application") in Sycamore Township Zoning Case Number 2018-16LASR; and

**WHEREAS**, the real property in Case No. 2018-16LASR, consists of the real property located at 7800 Montgomery Road Unit 17, Sycamore Township, Hamilton County, Ohio and is located in the parcel designated as Hamilton County Auditor's Parcel Number 600-0080-0178-00 (the "Real Property"); and

**WHEREAS**, the Owner and prior owners have previously received original approval of a Localized Area Sign Regulation Plan for Kenwood Square and has made various amendments to such plan; and

**WHEREAS**, the Real Property is located in an "E"- Retail District within the Kenwood Special Public Interest District requiring an approval of any changes to the approved LASR Plan; and

**WHEREAS**, on November 1, 2018, after proper notice having been given, the Board of Township Trustees of Sycamore Township held a public hearing to consider the Application for the major adjustment to the LASR Plan on the Real Property;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.**

The Application as set forth in the plans and specifications as presented to the Board of Township Trustees on November 1, 2018, consisting of the removal of all existing exterior building signs and the installation of two exterior wall signs that are no greater than 74.84 square feet each, one of which is to be located on the north

building façade and one of which is to be located on the south building facade is hereby approved.

**SECTION 2.**

Any use and improvements made to the Real Property which is the subject of this Resolution shall be constructed in complete compliance with the plans, specifications, and renderings submitted at the public hearing on November 1, 2018, all approvals and conditions contained in the original LASR approval, and any other approvals not in conflict with this resolution.

**SECTION 3.**

No Zoning Certificate shall be issued by the Zoning Administrator until:

- A) a Zoning Compliance Plan in compliance with this Resolution has been received and approved by the Zoning Administrator;
- B) all documents submitted for zoning certificates are fully coordinated and consistent with the approved Zoning Compliance Plan;

No building permit for actual construction shall be issued by the Hamilton County Building Commissioner before a Zoning Certificate is received from the Zoning Administrator.

**SECTION 4.**

No Final Zoning Certificate shall be issued by the Zoning Administrator until the development complies with all requirements contained in this Resolution and the Zoning Compliance.

**SECTION 5.**

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 6.**

This Resolution shall take effect on the earliest date allowed by law.


