	Fund to the Kemper Goldcoast Deerfield Debt Service Fund the sum of
	\$189,945.96.

SECTION 2.	The Fiscal Officer of the Township is hereby authorized and directed to
	transfer from the General Fund to the General Obligation Debt Service
	Fund the sum of \$345,828.24.

SECTION 3.	The Fiscal Officer of the Township is hereby authorized and directed to
	transfer from the Kenwood Central JEDZ Fund to the Road & Bridge
,	Fund the sum of \$125,000.00.

- The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Road & Bridge Fund the sum of \$125,000.00.
- The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Southwest JEDZ Fund to the Road & Bridge Fund the sum of \$125,000.00.
- The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Northwest JEDZ Fund to the Road & Bridge Fund the sum of \$125,000.00.
- SECTION 7. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund to the Fire Fund the sum of \$222,871.50.
- SECTION 8. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund to the Fire Fund the sum of \$222,871.50.

#### **SECTION 9.**

The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Southwest JEDZ Fund to the Fire Fund the sum of \$222,871.50.

#### **SECTION 10.**

The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Northwest JEDZ Fund to the Fire Fund the sum of \$222,871.50.

#### **SECTION 11.**

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

#### **SECTION 12.**

Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety and welfare of Sycamore Township and shall go into effect immediately. The reason for the emergency is to provide for the immediate reconciliation of budgets and appropriations for calendar year 2018.
