RESOLUTION NO. 2018 - 24

A RESOLUTION AMENDING THE EFFECTIVE DATE OF 2018 RATES OF PAY, AMENDING THE RATES OF PAY FOR TOWNSHIP EMPLOYEES, ESTABLISHING THE RATE OF PAY FOR A NEW TOWNSHIP EMPLOYEE AND DISPENSING WITH THE SECOND READING

WHEREAS, Resolution 2018-159 passed December 21, 2017 made the changes in rates of pay for Township effective January 1, 2018 when such effective date should have been December 17, 2017; and

WHEREAS, the Board of Township Trustees has entered into a new collective bargaining agreement with members of the International Association of Fire Fighters Local 3907 which sets forth new rates of pay for union members to be effective December 17, 2017; and

WHEREAS, the Board of Township Trustees is hiring a new Township employee effective February 16, 2018 and desires to set his compensation as established under the new Local 3907 contract;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

All salaries and rates of pay established in Resolution 2018-159 shall be effective December 17, 2017 rather than January 1, 2018 and the Township Fiscal Officer is hereby authorized and directed to provide the correct compensation to Township employees based on that effective date.

SECTION 2.

The portion of Section 2 of Resolution 2018-159 which reads as follows:

"Members of the International Association of Fire Fighters Local 3907 Union shall be compensated pursuant to the contract between Sycamore Township and the union effective January 1, 2018.
