

RESOLUTION 2018- 38

A RESOLUTION AUTHORIZING A CONTRACT FOR THE PURCHASE OF TWO POLICE VEHICLES, THE TRADE IN OF TWO EXISTING POLICE VEHICLES AND DISPENSING WITH THE SECOND READING

WHEREAS, the Board of Township Trustees has determined that separate bids for the purchase of two 2018 Ford Explorer Police Interceptors would exceed the price available from Lebanon Ford which is less than the low bidder under the Ohio Cooperative Purchasing Program of which Sycamore Township is a member; and

WHEREAS, the Board of Township Trustees wishes to purchase the vehicles for use under contract between the Hamilton County Sheriff's Office and the Township for police protection services in the Township; and

WHEREAS, the Township owns a 2000 Ford Crown Victoria police vehicle VIN 2FAFP71W6YX103363 and a 2000 Ford Crown Victoria police vehicle VIN 2FAFP71W1YX165849 that are both obsolete and unfit for public use and the Board desires to sell the vehicles to Lebanon Ford and to have the selling price credited against the purchase price of the new vehicles pursuant to ORC 505.10(3);

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township Administrator is hereby authorized to acquire, through the Hamilton County Sheriff's Office, from Lebanon Ford, two (2) 2018 Ford Explorer Police Interceptors in an amount not to exceed \$30,000.00 per vehicle for a total of \$60,000.00.

SECTION 2. The Board hereby finds that the 2000 Ford Crown Victoria police vehicle VIN 2FAFP71W6YX103363 and the 2000 Ford Crown Victoria police vehicle VIN 2FAFP71W1YX165849 currently owned by Sycamore Township are both obsolete and unfit for public use and authorizes and directs that they be sold to Lebanon Ford and the selling prices for both vehicles be credited against the purchase price of the two 2018 Ford Explorer Police Interceptors.

SECTION 3. The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 4. This resolution shall take effect on the earliest date allowed by law.




