


SECTION 3. This Resolution shall take effect on the earliest date allowed by law.







RENEWAL AGREEMENT

This Renewal Agreement is made this 31st day of March, 2018, in Hamilton County, Ohio, pursuant to the laws of the State of Ohio, by and between the Sheriff of Hamilton County, Ohio ("Sheriff"), the Board of County Commissioners of Hamilton County, Ohio ("Board"), the Board of Township Trustees of Sycamore Township, Hamilton County, Ohio, ("Township"), pursuant to the Agreement for Police Protection Services dated April 1st, 2015 and amended on April ____, 2016.

WHEREAS, the Sheriff, the Board and the Township, pursuant to section to 504.16, 311.29, 505.43, or 505.50 of the Ohio Revised Code, currently have an Agreement, as amended on April ____, 2016 ("Agreement") where the Sheriff provides Police Protection Services to the Township, which Agreement which includes the April ____, 2016 amendment is incorporated into this Renewal Agreement as if fully rewritten herein; and

WHEREAS, Article 5.2 of the Agreement provides for a renewal period of one (1) subsequent year beginning March 31, 2018, by mutual written agreement of the parties; and

WHEREAS, the Township has agreed to renew the Agreement for a period of one year effective March 31, 2018, pursuant to the terms and conditions set forth in the Agreement, as amended, and the Township has appropriated the necessary funds therefor, and the Sheriff and the Board wish to enter into this Renewal Agreement;

NOW THEREFORE, incorporating these Premises, and in consideration of the mutual covenants, terms and conditions contained herein and in the Agreement, the Parties agree as follows:

1. The Agreement shall be renewed from March 31st, 2018 until April 1st, 2019 (regardless of execution date) on the terms and conditions set for in the Agreement.
2. All other terms and conditions of the Agreement, as amended, shall remain in full force and effect as written.
