This Renewal Agreement is made this 31<sup>st</sup> day of March, 2018, in Hamilton County, Ohio, pursuant to the laws of the State of Ohio, by and between the Sheriff of Hamilton County, Ohio ("Sheriff"), the Board of County Commissioners of Hamilton County, Ohio ("Board"), the Board of Township Trustees of Sycamore Township, Hamilton County, Ohio, ("Township"), pursuant to the Agreement for Police Protection Services dated April 1<sup>st</sup>, 2015 and amended on April \_\_\_\_\_, 2016.

WHEREAS, the Township has agreed to renew the Agreement for a period of one year effective March 31, 2018, pursuant to the terms and conditions set forth in the Agreement, as amended, and the Township has appropriated the necessary funds therefor, and the Sheriff and the Board wish to enter into this Renewal Agreement;

NOW THEREFORE, incorporating these Premises, and in consideration of the mutual covenants, terms and conditions contained herein and in the Agreement, the Parties agree as follows:

- 1. The Agreement shall be renewed from March 31<sup>st</sup>, 2018 until April 1<sup>st</sup>, 2019 (regardless of execution date) on the terms and conditions set for in the Agreement.
- 2. All other terms and conditions of the Agreement, as amended, shall remain in full force and effect as written.
