**RESOLUTION 2018-54**

**A RESOLUTION AUTHORIZING A CONTRACT FOR THE 2018 CURB AND  
SIDEWALK REPLACEMENT PROGRAM AND DISPENSING WITH A SECOND  
READING**

**WHEREAS**, the Board of Township Trustees is desirous of making improvements and repairs to curbs and sidewalks in the Township on the following streets: Spirea Drive, Duneden Drive, Largo drive, StyraX Drive, Dartmoor Court, Alhambra Court, Applewood Drive, Valerie Court, Winesap Court and Blossom Drive (the "2018 Curb and Sidewalk Replacement Program"); and

**WHEREAS**, the Township caused plans and specifications for the 2018 Curb and Sidewalk Replacement Program to be prepared and advertised for bids as required by state law; and

**WHEREAS**, Prus Construction Company submitted a bid in the total amount of \$392,725.00 in accordance with the plans and specifications prepared by the Township; and

**WHEREAS**, the proposal submitted by Prus Construction Company was the lowest and best bid received;

**NOW THEREFORE, BE IT RESOLVED** by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** That the President of the Board and Fiscal Officer are hereby authorized and directed to contract with Prus Construction Company to provide for the 2018 Curb and Sidewalk Replacement Program as set forth in the plans and specifications prepared by the Township for the project.

**SECTION 2.** Such contract shall provide that Prus Construction Company shall provide and furnish all of the labor, materials, tools, expendable equipment, and all utility, insurance and transportation services required in accordance with the plans and specifications prepared by the Township, which plans and specifications shall be made a part of such contract.

**SECTION 3.** Subject to additions and deletions contained therein, the contract price shall not exceed \$392,725.00.

**SECTION 4.** The Board of Township Trustees of Sycamore Township, by at least two-third vote of all of its members, dispenses with any requirement that this Ordinance be read on two separate days and authorizes its passage upon one reading.


**SECTION 5.**


This Resolution shall take effect on the earliest date allowed by law.






