RESOLUTION NO. 2018 - 56

**A RESOLUTION APPROVING A MAJOR ADJUSTMENT TO THE MARCH FIRST
BREWING PLANNED UNIT DEVELOPMENT AND DISPENSING WITH A
SECOND READING**

WHEREAS, application (the "Application") was made by Kevin Kluener (the "Applicant") on behalf of Contingent Holdings LLC (the "Owner") for approval of a major adjustment to a planned unit development to add parking, construct a patio with outdoor seating, construct a cedar dumpster enclosure, and change the existing storage and office space to a taproom and manufacturing for the real property located at 7885 East Kemper Road, Sycamore Township, Hamilton County, Ohio (the "Application") in Sycamore Township Zoning Case No. 2018-07MA; and

WHEREAS, the real property in Case No. 2018-07MA, consists of the real property located at 7885 East Kemper Road, Sycamore Township, Hamilton County, Ohio and is designated as Hamilton County Auditor's Parcel Number 600-00130121-00 (the "Real Property"); and

WHEREAS, the Real Property is located in an "FF"- Planned Light Industrial District requiring an approval of any changes to an approved Plan; and

WHEREAS, on April 9, 2018, after proper notice having been given, the Sycamore Township Zoning Commission held a public hearing to consider the Application for the major adjustment to the plan on the Real Property; and

WHEREAS, on April 9, 2018, the Sycamore Township Zoning Commission recommended approval of the Application with conditions; and

WHEREAS, on May 3, 2018, after proper notice having been given, the Board of Township Trustees of Sycamore Township held a public hearing to consider the Application for the major adjustment to the plan for the Real Property;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The Application as set forth in the plans and specifications as presented to the Board of Township Trustees on May 3, 2018, is hereby approved with the following conditions:

1. All exterior mechanical units shall be screened;
2. A lighting plan compliant with the Sycamore Township Zoning Resolution shall be submitted and constructed;

3. All supplies shall be stored inside the building;
4. A parking plan compliant with the Sycamore Township Zoning Resolution shall be submitted and constructed;
5. All plantings and landscaping shall be compliant with the Sycamore Township Zoning Resolution;
6. The dumpster enclosure may be constructed of cedar as proposed;
7. All vehicles must be parked on paved surfaces; there shall be no parking of vehicles in any grass area.

SECTION 2.

Except as amended herein, any use and improvements to the Real Property which is the subject of this Resolution shall be in complete compliance with previous approved applications for the Real Property.

SECTION 3.

No Zoning Certificate shall be issued by the Zoning Administrator until:

- A) a Zoning Compliance Plan in compliance with this Resolution has been received and approved by the Zoning Administrator if required;
- B) all documents submitted for zoning certificates are fully coordinated and consistent with the approved Zoning Compliance Plan if required;

No building permit for actual construction shall be issued by the Hamilton County Building Commissioner before a Zoning Certificate is received from the Zoning Administrator.

SECTION 4.

No Final Zoning Certificate shall be issued by the Zoning Administrator until the development complies with all requirements contained in this Resolution and the Zoning Compliance Plan if required.

SECTION 5.

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 6.

This Resolution shall take effect on the earliest date allowed by law.


