A RESOLUTION APPROVING A CONTRACT FOR 2018 ONYX ROAD REPAIR PROJECT AND DISPENSING WITH THE SECOND READING

WHEREAS, the Board of Township Trustees wishes to continue in 2018 the program of treating pavements with Onyx road repair material in order to prolong the life of streets and roads in the Township ("the 2018 Onyx Road Repair Project"); and

WHEREAS, the Board of Township Trustees hereby approves the following streets to be included in the 2018 program of road repair using Onyx road repair material: Lynchris Drive, Sandymar Drive, Finley Lane, Gideon Lane, Ironwood Court, Millview Drive, Brookbridge Drive, and Pinecove Drive ("the 2018 Onyx Road Repair Project"); and

WHEREAS, Strawser Construction, Inc. submitted the lowest and best proposal for the 2018 Onyx Road Repair Project;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The attached proposal for the 2018 Onyx Road Repair Project from Strawser Construction, Inc. in the amount of \$49,435.02 is hereby accepted and approved and the Township Administrator is hereby authorized and directed to contract with Strawser Construction, Inc. to provide for the 2018 Onyx Road Repair Project. In addition, Strawser Construction, Inc. shall provide remedial repair services as set forth on the attached schedule at no cost to the Township.

SECTION 2.

The contract with Strawser Construction, Inc. shall provide all of the necessary requirements in accordance with the proposal submitted by Strawser Construction, Inc.

SECTION 3.

Subject to additions and deletions contained therein, the contract price with Strawser Construction, Inc. shall not exceed \$49,435.02.

SECTION 4.

The Township Trustees of Sycamore Township, upon at least a majority vote, do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

SECTION 5.

This Resolution shall take effect on the earliest date allowed by law.
