WHEREAS, the Board of Township Trustees contracted with Choice One Engineering Corporation for the surveying, designing, engineering, construction and bidding document services for the Kugler Mill Improvement Project; and

WHEREAS, the Board of Township Trustees desires to approve an amendment to the contract with Choice One Engineering Corporation for the surveying, designing, engineering, construction and bidding document services for the Kugler Mill Improvement Project

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1.

The attached amendment to the agreement with Choice One Engineering Corporation is hereby approved and the Township Administrator is hereby authorized and directed to contract with Choice One Engineering Corporation to provide for the additional work for the surveying, designing, engineering, construction and bidding documents for the Kugler Mill Improvement Project.

The Board of Township Trustees of Sycamore Township, by at least twothird vote of all of its members, dispenses with any requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.





Scope of Services

Project Services

The Scope of Services will be expanded to include the following:

- 1. Phase B Design
 - a. Revise storm sewer design east of Kenwood Road and west of New England Court. Revised design will modify storm sewer leading up to and coming out of the existing outlet at STA. 53+00. See attached exhibit.
 - b. The intent of this design is to hold water back at this outlet without water backing up and flooding Kugler Mill Road or nearby properties.
 - c. Submit updated plans and storm calculations to Hamilton County for approval.
 - d. Revise plans to account for county comments.
- 2. Establishment Plat and Legal Descriptions
 - a. Prepare an Establishment Plat (per Pippen Road example attached) showing details of Kugler Mill Road such as:
 - i. Centerline information
 - ii. Owner name and address
 - iii. Easement parcel number
 - iv. Bearing/Distance information for new easements
 - v. Colored hatching to identify easement types
 - b. Prepare metes and bounds legal descriptions for the new easement parcels.
 - c. Parcels that require easements shown on attachment.


