

RESOLUTION 2019 - 93

A RESOLUTION DESIGNATING NO PARKING ON A PORTION OF CERTAIN STREETS IN THE ROSSMOYNE/DILLONVALE AREA OF SYCAMORE TOWNSHIP AND DISPENSING WITH A SECOND READING

WHEREAS, in order to provide for safe streets and roads in Sycamore Township, Ohio;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Smallwood Lane, a dedicated road in Sycamore Township, there shall be no parking in the cul-de-sac area of Smallwood Lane beginning on the south side of Smallwood Lane two hundred seventy feet (270') east of the intersection of Smallwood Lane and Williams Street and continuing to a point on the north side of Smallwood Lane, two hundred sixty feet (260') east of the intersection of Smallwood Lane and Williams Street.

SECTION 2. Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Limerick Avenue, a dedicated road in Sycamore Township, there shall be no parking on the north side of Limerick Avenue starting at a point eight hundred feet (800') west of the intersection of Limerick Avenue and Mantell Avenue and continuing west a distance of two hundred feet (200').

SECTION 3. Due to indiscriminate parking and to insure the free movement of vehicles and emergency vehicles on Larchview Drive a dedicated road in Sycamore Township, there shall be no parking on the south side of Larchview Drive starting at the intersection of Larchview Drive and Glenbar Court and continuing east a distance of four hundred feet (400').

SECTION 4. The Township Maintenance Department shall install the appropriate signage as required by law to enforce this Resolution.



SECTION 6. This Resolution shall take effect at the earliest possible date allowed by law.


