

RESOLUTION NO. 2020 - 84

A RESOLUTION AUTHORIZING AND DIRECTING TRANSFERS OF FUNDS TO RECONCILE BUDGETS AND APPROPRIATIONS AND DISPENSING WITH A SECOND READING

WHEREAS, in order to reconcile budgets and appropriations for calendar year 2020;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kemper Goldcoast Deerfield Tax Increment Financing Fund (33) to the Kemper Goldcoast Deerfield Debt Service Fund (35) the sum of \$194,500.00.

SECTION 2. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the General Fund (01) to the General Obligation Debt Service Fund (42) the sum of \$271,800.00.

SECTION 3. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund (70) to the Road & Bridge Fund (04) the sum of \$288,000.

SECTION 4. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund (71) to the Road & Bridge Fund (04) the sum of \$288,000.

SECTION 5. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund (70) to the Fire Fund (10) the sum of \$650,000.00.

SECTION 6. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund (71) to the Fire Fund (10) the sum of \$650,000.00.

SECTION 7. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood Central JEDZ Fund (70) to the Police Fund (09) the sum of \$400,000.00.

SECTION 8. The Fiscal Officer of the Township is hereby authorized and directed to transfer from the Kenwood East JEDZ Fund (71) to the Police Fund (09) the sum of \$400,000.00.

SECTION 9.

The Fiscal Officer of the Township is hereby authorized and directed to transfer from the General Fund (01) to the Mandatory Law Enforcement Fund (08) the sum of \$16,516.01.

SECTION 10..

The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with any requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.


SECTION 11.

This resolution shall take effect on the earliest date allowed by law.






